#### **ROSE TRACZYK MASTEY**

## MEETING THE CHALLENGE. ACHIEVING HER DREAM.

It hasn't been an easy road for Rose Traczyk Mastey. But she's not going to quit until she achieves her lifelong goal of becoming a nurse.

"I've wanted to be a nurse for as long as I can remember," she says. "I used to dress up as Florence Nightingale for Halloween even though nobody knew who I was!"

Back in high school, Rose was diagnosed with brittle juvenile diabetes. She spent lots of time at the doctor's office, which only strengthened her resolve to help others by becoming a nurse. Soon after graduating, she was accepted into a four-year nursing program.

Rose struggled to keep up with a rigorous schedule that included both work and school. Due to her previous health condition and fatigue, she ended up in intensive care for three weeks, and was forced to drop out of the nursing program. But Rose refused to give up.

"In my early 30s, I went back to school to work on a Medical Laboratory Technician degree," she recalls. "I found a good job where I worked for seven years, but I still really wanted to be a nurse. Unfortunately, around this time I went into end-stage renal disease as a result of my diabetes."

Rose received a double-organ kidney/pancreas transplant, and, remarkably, she regained her health with a stronger desire than ever to become a Registered Nurse.

"After the transplant, I felt like nothing could stop me. My husband encouraged me to take some nursing courses, so I enrolled at lvy Tech."

In search of financial assistance, Rose applied for the Ivy Tech Chancellor's Scholarship Award. She received the scholarship along with additional financial support from emergency aid grants made possible through Ivy Tech license plate fees from the BMV, as well as donations from individual donors.

Emergency aid grants and many other scholarship opportunities are available to students who need a little extra help to achieve their dreams. As for Rose, she's grateful for the opportunity—and she's still as ambitious as ever.

"I take pride in being an Ivy Tech student. Being here has helped make me even more determined, more goal-oriented. I have total confidence in myself. And I'm confident that I'm going to be a Registered Nurse, and graduate this December from Ivy Tech."

### LICENSE PLATE FEES AND EMERGENCY GRANTS

Many students at Ivy Tech experience significant financial barriers while they're enrolled in school. To support our students across the state, we've created emergency aid grants to help keep their academic careers on track.

To access these funds, students must meet with a Financial Coach who will help them identify the cause of the shortfall and ways to make sustainable change. Emergency grants are funded through lvy Tech license plate purchases (\$25 toward emergency grants per plate).

On April 7, 2017, Ivy Tech Community College Southwest honored the memory of Barbara J. Hilton by dedicating the Ivy Tech Barbara J. Hilton School of Nursing. This dedication was made possible by a generous gift from Barbara's husband, Dr. Frank L. Hilton.

Barbara was a dedicated mother, wife, friend, and nurse. The gift in her name was especially appropriate because Barbara understood how difficult it could be to balance life, family, and nursing school all at once—something she managed to do successfully while graduating at the top of her nursing school class. Barbara went on to work as an RN at St. Mary's Medical Center for nearly a decade, and also as an RN at Bristol-Myers, among other jobs in the healthcare field.

The gift from the Hilton family will allow new equipment and supplies to be purchased at the school for years to come, and help keep lvy Tech's nursing students up to date with the latest trends in the industry. It will also help fund the Barbara J. Hilton Nursing Scholarship for students in the program.

The School of Nursing has approximately 140 nursing majors in its Associate of Science in Nursing and Licensed Practical Nursing Programs. There are another 300 students taking coursework in hope of being accepted into the programs. The School of Nursing was recently ranked 2nd in the state for its students' high pass rates on the NCLEX exam.

In recognition of Barbara's accomplishments, we're proud to dedicate the Ivy Tech Barbara J. Hilton School of Nursing in her name. Her memory will undoubtedly be an inspiration to nursing students for years to come.

# HELPING STUDENTS DEVELOP THE SKILLS THEY NEED TO SUCCEED.

To give more students access to meaningful, hands-on job training opportunities, lvy Tech partners with many companies and organizations around the state. Several of these organizations have generously donated gifts in kind to help lvy Tech students get the experience they need to succeed in the real world.



#### PARKVIEW HEALTH

The demand for nurses and other healthcare professionals is higher than ever. To help keep up with the growing need, Parkview Health in Fort Wayne will open the Parkview Education Center this fall. The new facility represents a partnership between Parkview Health, Ivy Tech Northeast, and Fort Wayne Community Schools' Career Academy at Anthis.

Ivy Tech will have four classrooms, two anatomy and physiology labs, two computer labs, one EKG lab, one phlebotomy lab, one kinesiology lab, and a possible fifth classroom and pharmacy technician lab at the Parkview Education Center. These resources will provide valuable education opportunities for Ivy Tech students in Northeast Indiana for years to come.



#### **TOYOTA**

Toyota has been a long-time partner with Ivy Tech, and they've generously donated more than 50 automobiles to the Automotive Technology Program. These cars help give students practical experience working on brakes, transmissions, electrical systems, suspensions, engines, and more. # NEW OPPORTUNITIES TO HELP STUDENTS REACH THEIR GOALS.

The Ivy Tech Foundation established the Women in Philanthropy Circle of Ivy to raise funds and eliminate barriers to higher education for Ivy Tech students. The Circle of Ivy, founded in 2015, cultivates and celebrates women as philanthropists. Founded in 2015 with 137 inaugural members, it has now grown to almost 300 members with goals and aspirations to make an even bigger impact throughout the state at each member's local campus.

Last year, the Circle of Ivy initiative raised almost \$70,000 at their October luncheon. Regional members selected projects based on submitted proposals to decide how to best allocate the funds. Here are the results:
